#### **Approval of Minutes**

The minutes of the previous meeting held virtually on November 4, 2022, were approved by an online vote by the membership in October 2023.

# **Membership Report**

AASLD now has 7.312 members. 2022-2023 Membership Year- June 30, 2023 1,00 New Members. 8.6 percent Growth rate 82 percent retention rate

# **AASLD Bylaw Change**

Approved Change to Terms – Title II, Section III in AASLD Bylaws: *The Councilor-at-Large, Secretary and Treasurer are eligible for nomination as Councilor after four years off the Board. The Councilor-at-Large is eligible for nomination as Secretary or Treasurer after four years off the Board.* This was passed with an overwhelming majority by our members.

#### REPORT OF THE TREASURER

Dr. Taddei reported that AASLD and the AASLD Foundation Financial Statements for FY2023 (July 1, 2022, to June 30, 2023) were audited. The Finance Committee, which oversees the financial and investment activities of AASLD, reviewed the independent auditor's reports by GRF CPAs & Advisors.

The Governing Board reviewed and approved the FY2022 audit reports on October 20, 2022. The auditors reported that the financial positions for AASLD and the AASLD Foundation were strong and rendered an unmodified (clean) opinion regarding the finances and internal control procedures, the best audit report opinion any organization can receive.

## **Highlights of FY 2023:**

- Revenue increased mostly from successful annual meeting and sponsorships income compared to the prior year.
- Expenses: Overall, we done a great job and were able to retain most of the program expenses within budget. We increased our efforts in engagement and global outreach program and as a result higher expenses were incurred in these categories.
- 87% of total expenses were spent on programs and 13% on leadership and administration compared to industry best practices of 77% and 23%, respectively.

#### **AASLD FOUNDATION**

Dr. Bruce Luxon reported that the Foundation funded over \$2 million in funding towards awards and education. The Research & Career Development award recipients, selected from a highly competitive applicant pool, demonstrated both exceptional aptitude and deep interest in liver disease research and treatment.

Dr. Luxon highlighted the Foundation's impact including:

- 1. Funded over 1900 PEOPLE investing \$60M in our specialty.
- Supported people in 46 states and 45 countries through our research grants, training program, or by giving travel awards for those very far away.
- 3. Invested in the RIGHT People, for every dollar the Foundation invested from 2014 2021 has resulted in \$6.19 in NIH Follow on Funding so far.

## Leadership Giving Challenge:

- 72 percent of members serving on a Committee or SIG Committee made a gift to the Foundation during the campaign period.
- Three teams hit the competition hard and fully supported the Foundation very early in the Challenge.
- Women's Initiative Committee won the Challenge.
- Second place team is the Hepatotoxicity SIG
- Third Place the Practice Metrics Committee
- 17 of 42 teams competing in 2023 had 100 percent participation – this compares to 5 percent in 2022.

Dr. Luxon's term ends 12/31/2023. He introduced the new Foundation Board Chair, Kimberly A. Brown, MD, FAASLD. Chair from January 1, 2024-December 31, 2026.
